Key Summaries

- PalFed is meant to provide a way to share food with friends. Its purpose is not for selling food to the public.
- PalFed is not responsible for anything that happens as a part of any food sharing. If someone gets food poisoning, has an allergic reaction, doesn't turn up, or gets in a fight with another friend, that's not our problem, even if it is a result of a fault with our system.
- Adverts are limited to single menu items from nearby restaurants, take-outs and other food related businesses. We use (but do not share) your like and dislike tags to help determine menu items that might appeal to you.
- In order to know who of your friends and which of our advertisers are nearby, we need to know your location. You have the option not to share this information, in which case we will not show you local menu items or nearby friends. Your location is not used in any other way, or shared with third parties.
- All the standard stuff that companies put in their terms to protect us all from abuse and breaking the law.
- Make sure to read the full terms before accepting. The summary above does not cover all specifics, but aims to give a comprehensive high level overview.

Acceptance of the Terms of Use

Welcome to the website of PalFed, L.L.C. ("**Company**," "**we**" or "**us**"). These terms and conditions, together with the Privacy Policy and any other documents expressly incorporated by reference (collectively, the "Terms of Use") govern your access and use of www.palfed.com (the "**Website**"), including any content, functionality, services offered, or transactions conducted through the Website, whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Website. By using the Website or by clicking to accept or agree to the Terms of Use when this option is made available to you, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy. If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Website.

The website was created as a means to list food that you have prepared to your network of friends, or identify food you wish to consume. There may also be clearly marked advertising. We recommend that you only eat food made by friends who exhibit proper hygiene in food preparation. If uncertain, you should ensure that the proper permits exist to serve food. We are not responsible for any food that you might eat as a result of using the website, or for the actions of people who claim portions of food you are making. We are not liable in any way for any effect you may experience as a result of eating any food associated with the Website or for any losses or inconvenience experienced as a result of using the website.

Private Individuals:

- Must be acting within all local laws related to food preparation.

- May not sell or serve food to the public unless the required local permits have been issued and are in order.

Businesses:

- May not make friend requests without explicit permission from an individual.
- May register for the corporate account.
- With a corporate account, may create as many sponsored menu items as desired to be shown to users regardless of friend status on the website.
- Must be acting within all local laws relating to selling food and the specific services offered.
- A "regular posting" is defined as a menu posting made by the user representing the business. Its reach is to all friends connected with the user on PalFed and as a menu item via the mutual friend finder. Sponsored Items are not regular postings.
- To prevent spamming, businesses:
 - May not have more than one regular posting active on any one day.
 - May not have more than seven regular postings active at any one time.

The Website does not sell the food offered. It only provides the service to list or advertise what is being made. The Company and Website are not involved in any financial transactions that may take place between two or more users of the website.

The Company is not responsible for and cannot be held liable for any issues that arise from using the website as it is intended, including but not limited to:

- People not attending meals, or picking up food that has been claimed.
- Food poisoning, allergic reactions or other medical issues resulting from consuming food.
- Undesirable actions of people during a meal, when collecting portions, or during any other interactions related to this service.

Payments

Payments for account upgrades are made via Stripe through their secure payment API. Payments made to the company will appear on your credit card statement as "PalFed, L.L.C.". If you choose to setup automatic payment, your card details will be stored securely by Stripe

Changes to the Terms of Use
